

Public Offer Contract

1. General Provisions:

- 1.1. This document is a formal offer (Public Offer) by Sport Public Organization "Interregional Masters' Speed Skating Union", hereinafter referred to as the Organizer of the Competition, to a fully legally competent person, hereinafter referred to as the Participant of the Competition, who will accept the offer on the following conditions.
- 1.2. In accordance with paragraph 2, article 437 of the Civil Code of the Russian Federation, upon the acceptance of the conditions set forth below and payment of contributions, a legal or natural entity shall be considered the Participant of the Competition (in accordance with paragraph 3, article 438 of the Civil Code of the Russian Federation, offer acceptance is equal to the conclusion of a Contract on terms and conditions set forth in the offer).
- 1.3. The acceptance of the Organizer's offer by the Participant of the Competition shall be considered full and unconditional since the moment of confirmation of the Participant's willingness to pay earmarked contribution(s) to the Organizer of the Competition by clicking "Pay" on the website <http://www.imssur.ru/ISG2018/pay/>. - 1.4. Accepting the Offer as it is indicated in clause 1.3 hereof, the Participant of the Competition confirms that he/she is familiar with all terms and conditions of the Contract, fully and unconditionally agrees with them and accepts all provisions as outlined in the text of the Contract, including those indicated in the Annex representing an integral part thereof.
- 1.5. The Participant of the Competition agrees that acceptance of the offer in accordance with the procedure referred to in clause 1.2 hereof is concluding the Contract under the conditions set out therein.
- 1.6. The Contract shall be irrevocable.
- 1.7. The Contract shall not have to be sealed nor signed by the Participant and the Organizer of the Competition, hereinafter collectively referred to as the Parties, to maintain its legal force.

2. Subject of the Contract:

- 2.1. Subject of the Contract is the payment of earmarked contributions for participation in the 10th Masters' International Sprint Games that that will take place in Moscow on March 3-4, 2018 at the synthetic ice track of Krylatskoye Sports Complex, in accordance with the terms of this Contract.
- 2.2. In accordance with this Contract, the Participant of the Competition shall completely accept its terms and conditions and pay earmarked contributions to the Organizer of the Competition.

3. Payment of Earmarked Contributions:

- 3.1. The amount of and timeframe for earmarked contribution payment due (No. 1-3) are determined in accordance with the applicable Announcement on the 10th Masters' International Spring Games spelled out on [http://imssur.ru/ISG2018/Announcement_Moscow_2018_\(rus\).pdf](http://imssur.ru/ISG2018/Announcement_Moscow_2018_(rus).pdf) and http://imssur.ru/ISG2018/Announcement_Moscow_2018.pdf.
- 3.2. Methods of earmarked contribution payment are specified at the stage of payment arrangement.

4. Special Conditions and Liability of the Parties:

- 4.1. The Organizer shall carry out the competition timely and guarantee the compliance of the event with the terms of the Announcement on the 10th Masters' International Spring Games spelled out on the websites [http://imssur.ru/ISG2018/Announcement_Moscow_2018_\(rus\).pdf](http://imssur.ru/ISG2018/Announcement_Moscow_2018_(rus).pdf) and http://imssur.ru/ISG2018/Announcement_Moscow_2018.pdf.
- 4.2. The Organizer of the Competition shall be exempted from liability for violation of contract terms, if such violation is caused by force majeure circumstances, including actions of public authorities, fire, flood, earthquake, other acts of God, lack of electricity, strikes, civil unrest, riots and any other circumstances, without limitation to those listed, which may affect the performance of the terms of the Contract by the Organizer.
- 4.3. The Organizer of the Competition shall not be responsible for the quality of public communication channels or the performance of services providing the Participant's access to them.

5. Confidentiality and Personal Data Protection:

- 5.1. The Organizer of the Competition shall not disclose any information obtained from the Participant of the Competition.
- 5.2. The disclosure of information shall not be considered a violation of obligations if carried out in accordance with reasonable and applicable requirements of the law.
- 5.3. The Organizer of the Competition receives information about the IP address of a visitor of the website <http://www.imssur.ru/ISG2018/>. This information shall not be used to identify the visitor.
- 5.4. The Organizer of the Competition shall not be responsible for the information provided by the Participant of the Competition on the website <http://www.imssur.ru/ISG2018/> in a public form.

6. Complaint and Dispute Handling:

- 6.1. The Participant's complaints on the services provided shall be accepted for the Organizer's consideration by e-mail (vladimirletunov@yandex.ru) within 5 (five) business days from the moment of occurrence of the disputable situation.

7. Other Terms and Conditions:

- 7.1. The Organizer of the Competition has all the rights and powers to conclude and execute the Contract.
- 7.2. The Participant of the Competition has the right to refuse to participate in the Competition. In case of a reasoned refusal, the amount of the earmarked contribution(s) paid by the Participant of the Competition may be partially refunded within 30 business days.
- 7.3. The Organizer of the Competition reserves the right to amend and supplement any terms and conditions of this Contract at any time by publishing them on the Organizer's website.
- 7.4. All issues not covered by this Contract shall be regulated in accordance with the legislation of the Russian Federation.
- 7.5. Nullification of any provision or regulation of this Contract shall not entail nullification of other provisions.
